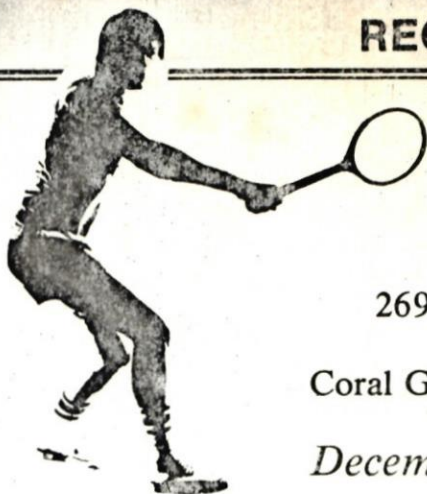

ELIGIBILITY:

- ✓ U.S. and Foreign Players International Age Rules Apply
- ✓ 14 and under-those born on or after January 1, 1972.
- ✓ With the exception of the United States, each country is limited to 4 players. Selection is subject to the discretion of the Tournament Committee.

ENTRY

DEADLINE:

Applications must be received by 5 p.m., November 29, 1986. No phone entries will be accepted. Tournament records and ranking information should be included if the player wants to be considered for seeding. A stamped, self-addressed post card must be enclosed with the application, this card will be returned to notify the player that the application has been received. Foreign applications will be accepted only from the federations. No application will be considered unless it is accompanied by the entry fee of \$40.00 (U.S. Dollars).

DRAW:

No player may enter more than one division of the Junior Orange Bowl, 14, 16, 18. The draw will be made December 10, 1986. No refunds will be made after the deadline date of November 29, 1986. Acceptance into the draw will be available ONLY at (305) 443-6996 December 12 and 13 from 2-10 p.m. INFORMATION ABOUT THE DRAW WILL NOT BE AVAILABLE AT OTHER TIMES.

There will be a dinner for players December 18 from 6-8 p.m. at the Miami Marriott Hotel. Players will receive a free ticket at registration.

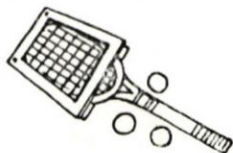
FEED-IN CHAMPIONSHIPS:
