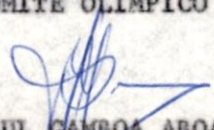

GUIDELINES, RULES AND REGULATIONS, OPERATIONAL POLICIES OF THE WTF AND PATU CONCERNING WTF INTERNATIONAL REFEREES AND THE PAN AMERICAN REFEREES

- 2.1 Both the WTF and the PATU require that all international referees (I.R.) and Pan American Referees pay annual referee dues and encourage participation in the national, regional, PATU and WTF championships, as well as WTF or PATU sponsored "REFEREES' REFRESHER COURSE". The Pan American Referee Certification is going to be prerequisite for the WTF's International Referee Certification.
- 2.2 Candidates for the Pan American Referee Certification shall comply with the following specifications. The candidates:
- (a) must hold a KUKKIWON certified 2nd Dan or higher;
 - (b) must have completed at least high school;
 - (c) must be recommended by the PATU member national Taekwondo organization's President or the President of PATU.
 - (d) must be tall (168 cm minimum height for man and 162 cm for woman) with excellent vision.
- 2.3 Restrictions and Reference:
- (a) PATU member national association shall be limited to five (5) nominees at each Pan American Referee Certification Seminar, except the country where the Pan American Certification Seminar is to be held.
 - (b) This restriction may be waived by the President of PATU at his discretion for special circumstances.
 - (c) PATU member nations which do not have KUKKIWON certification 2nd Dan or higher should consult with Dr. Dong Ja Yang, President, PATU.
- 2.4 Application and fees:
- (a) The application and appropriate fees must be submitted to the PATU upon the registration in Indianapolis, Indiana, USA, for all candidates from outside the USA.
 - (b) The application must be submitted with the appropriate fees to the Headquarters of PATU by July 30, 1987, for all candidates from the USA.
 - (c) Seminar fees of U.S.\$250.00 for the Pan American Referee Certification Seminar must be paid by a certified check or money order.
 - (d) PATU Seminar fees can be reduced for those participants from the more needy countries.
 - (e) WTF Certified International Referees' Refresher Course fees are U.S.\$150.00.
 - (f) PATU Certified Pan American Referees' Refresher Course fees are U.S.\$150.00.

2.5 Items to bring:

- (a) Taekwondo Dobok (WTF official uniform only) and warm-ups.
- (b) White Taekwondo shoes (Maste Shoes) or Tennis shoes.
- (c) Notebook, pens, etc.
- (d) WTF or PATU Referee suit and shirts (yellow).
- (e) Kukkiwon Dan original I.D. Card, and a copy of the Kukkiwon Dan certificate.

2.6 Accommodations:

- (c) Hotel rooms are very expensive according to the class and location of the hotel, especially at the Pan American Games site in Indianapolis. We estimate a price range from U.S.\$60.00 to U.S.\$120.00 per day.
- (d) Only twenty (20) selected members of the Taekwondo referees in the Pan American countries will be staying at the Pan American Games village, all other referees and seminar participants must provide their own expenses (room and board, transportation and misc.)

THE REFEREES FOR
THE TAEKWONDO COMPETITION IN
THE XTH PAN AMERICAN GAMES (PAX/I)

3.1 A total of twenty (20) WTF Certified International Referees and/or PATU certified Pan American Referees have been selected by the PATU who will be the only accredited "REFEREES" by the Xth Pan American Games Organizing Committee. These referees have to comply with the following requirements. The referees:

- (a) must report by NOON of August 7, 1987, at the "Taekwondo Suite" at the Hyatt Regency Hotel, Indianapolis, Indiana;
- (b) must bring all items as described under #2.5, including most importantly...yellow colored WTF and PATU Referees' suite and shirts;

- (c) must stay in the Pan American Games village from August 7 through 17, 1987, where room and board and medical care will be provided by the Pan American Games Organizing Committee(PAX/I);
- (d) must attend all sessions of the Seminar;
- (e) must provide all personal expenses and airfare from and to their home city and Indianapolis, Indiana; and
- (f) must honor and endorse his/her signature on all required forms by PAX/I or PATU or WTF.

3.2 The referees under #3.1 shall be recognized:

- (a) by the award of the PATU Certificate of Achievement and Appreciation;
- (b) by the submission of a statement of commendary mention on his/her behalf to the WTF and PATU, as required for promotion in class of referees;
- (c) by the presentation of all commemorative items of Taekwondo of the Games; and
- (d) by a small amount of miscellaneous allowance per day (not more than U.S.\$10.00 per day), and remission of the Seminar fees.

3.3 A total of fifteen (15) additional WTF and/or PATU certified referees have been appointed or have been scheduled to be appointed by PATU. These fifteen (15) referees will not be accredited by the Pan American Games Organizing Committee (PAZ/I), but the PATU will provide its own accreditation. Even though these U.S. referees are well known internationally, they have generously accepted PATU's policy to take their own burden of expenses in order to provide greater opportunities for the referees from outside the USA.

3.4 The Referees under #3.3 shall comply with the following requirements. The referees:

- (a) must report and register for the Seminar on August 8, 1987, at the "Taekwondo Suite" at the Hyatt Regency Hotel in Indianapolis;
- (b) must bring all items as described under #2.5 including most importantly a "Yellow WTF and PATU referees' suit and shirts;
- (c) must provide own room and board and other personal expenses;
- (d) must attend all session of the Seminar; and
- (e) must honor and endorse by his/her signature on all required forms by PAX/I or PATU or WTF.

3.5 The referees under #3.3 shall be recognized and supported:

- (a) by the award of the PATU certificate of Achievement and Appreciation;
- (b) by the submission of a statement of commendary mention on his/her behalf to the WTF and PATU, as required for promotion in class of referees;
- (c) by the presentation of all commemorative items of Taekwondo competition of the Games; and
- (d) by the policy of remission of the Seminar fees.
