3 - AGE LIMIT

Men may participate in the Junior world Championship who are no more than 20 years of age of the 1st January of the year of the junior world championship. (For example: for the 1987 Junior Championship, players must be born after 31st December 1966.)

Eligibility to participate is confirmed by the Junior world Championship Jury the day before the beginning of the competition on the basis of passports or individual documents with photographs issued by a competent authority.

4 - METHOD OF COMPETITION

4.1 PRELIMINARY PHASE

Four groups (A, B, C, D) composed of four teams each, which play against one another according to the Round Robin System.

4.2 SEMI-FINAL PHASE

Two groups (E, F) composed of six teams each, which play against one another according to the round-robin system. The matches played during the preliminary phase will be taken into consideration, and will not be repeated.

4-3 CLASSIFICATION GROUP

The teams classified fourth in the groups of the eliminatory phase form one group in which they play against one another according to the Round Robin system to decide the positions thirteen to sixteen.

8 - Balls

The championship will be played with the official ball of the Mikasa VL200.

9 - Information

- 9.1 Delegations will consist of 18 persons including an international referee as per FIVB Administrative Regulations.
- 9.2 Each Federation will be responsible for any person exceeding the 18 persons and pay upon arrival the total amount of his reservation at an individual daily rate of US 100 including lodgin and 3 daily meals. The Bahrain Association will take care of reservations requested before July 1st 1987.
- 9.3 The Bahrain association will cover internal transportation and accommodation of invited referees appointed by FIVB I.R.C
- 9.4 In order to contribute to the proper development of the organizing program of the Championship all National Federations concerned are requested to furnish No LATER THAN July 1st 1987 all the supplementary information particularly list of players team photographs colours (at least two sets of Jerseys of different colours). etc.
- 9.5 FIVB Statutes, Internal Regulations and the Technical and Administrative Regulations for official competitions will be applied for all unforeseen cases.

10 - JURY

The championship will be directed by Jury headed by the president of the FIVB or his representative. The members of Jury will be composed of the president of S.O.C. The representative of the organizing country, a member of the players qualifying committee and two to four members designated by the FIVB Executive committee. In order to ensure regular check throughout the competition, different Jury members will be present at all match sites and will be responsible for the regular conduct of the competition.

It is the highest authority of the competition.

Its decisions take precedence, they are final and there can be no appeal.

11- Special Refereeing Committee

The special refereeing committee will be headed by the president of the international Refereeing committee or his representative. The members of S.R.C will be composed of the president of R.G.C or his representative the representative of the organizing country and three to five members recommended by I.R.C and ratified by the executive committee. It is the highest authority for all the referees scorers and linesmen participating in the competition.



12 - Medical Committee

12-1 the Bahrain Volleyball Association will appoint the medical committee in charge of the antidoping tests as well as first aid. The committee will be supervised by the president of the M.C of the FIVB or his representative.

12-2 Antidoping Tests

Per FIVB decision players will be subject to the anti - doping tests.

13 - VOLUNTARY FORFETTURE

If a team voluntarily declares a forfeit during match, it will be excluded from the competition and the results of matches it has already played during the respective phase will be annulled.

Starting from its elimination all expenses of that team will be charged to it and the FIVB may apply sanctions established in the Constitution and Internal Regulations.

14 - Substitution of teams

14-1 Up to the date of the definitive enrolments.

If a National Federation declares the non-participation of its duly qualified team or does not enroll before the given deadline it will be replaced by the team placed after it in the classification of the competition in which the defaulting team obtained its qualification.

14-2 After the date of definitive enrolment

If an enrolled team withdraws from the competition after the date of definitive enrolment, it will be replaced as follows:

a) Before the drawing of lots:

by the team nominated by the FIVB, bearing in mind the classification of the competition in which the defaulting team has qualified.

b) After the drawing of lots:

by the team nominated by the FIVB at the suggestion of the organizer.

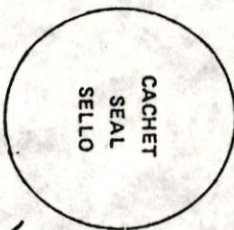
