



RESOLUCION No. 617-AD-88.

Visto el Oficio N°610 presentado por el Comité Olímpico Peruano, el cual ha motivado el expediente N°6144.

CONSIDERANDO :

Que, la entidad recurrente solicita autorización oficial para que el señor ROBERTO - ABUGATAS ABOID, viaje a la ciudad de Seul-Corea del 7 al 16 de Setiembre de 1988, a participar en el Congreso Mundial de Deportes ;

Con las opiniones favorables de la Dirección Nacional de Deporte de Afiliados, Oficina de Asesoría Jurídica y Dirección Ejecutiva Nacional; y visto el certificado médico;

De conformidad con el Art.9° numeral 12 y Art.77° del Decreto Legislativo N°328- Ley General del Deporte y su Reglamento aprobado por Decreto Supremo N°07-ED-86; y con cargo a dar cuenta al Consejo Nacional del Deporte ;

SE RESUELVE :

Artículo 1° .- AUTORIZAR, al Comité Olímpico Peruano para que el señor ROBERTO ABUGATAS ABOID viaje a la ciudad de Seul-Corea del 7 al 16 de Setiembre de 1988 a participar en el Congreso Mundial de Deportes.

Artículo 2° .- De conformidad con el Art.77° establecido por el Decreto Legislativo N°328 y reglamentado por el Art.76° del Decreto Supremo N°07-ED del 13-03-86, el indicado participante está exonerado de los impuestos sobre signos de aviación a que se contrae el Decreto Legislativo N°209 sobre impuestos a los bienes y servicios del Decreto Ley N°22317 modificado por el Art.2° del citado Decreto Legislativo N°209 y del impuesto a los viajes al exterior de los Decretos Leyes N° 22317 y 24030.

Artículo 3° .- El costo que ocasione el indicado viaje, afectará el presupuesto del Comité Olímpico Peruano - Recursos Propios.

Artículo 4° .- La presente Resolución NO AUTORIZA la adquisición de moneda extranjera en el Mercado Unico de Cambios ni en Mesa de Negociaciones.

Artículo 5° .- Al término del citado Congreso Mundial, el Comité Olímpico Peruano - tiene quince (15) días para emitir su Informe Técnico-Económico a la Dirección Nacional de Deporte de Afiliados, el incumplimiento a esta disposición, - originará que el Instituto Peruano del Deporte no de trámite al próximo pedido de autorización de viaje al extranjero.

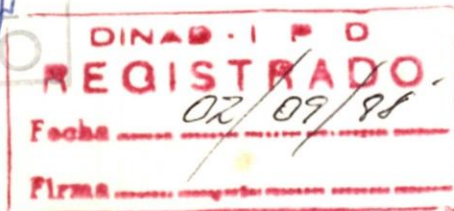

I am happy to report that you have been selected as a delegate to attend the World Congress on Sports in Seoul, Korea, September 7-16, 1988. This Congress is designed to train individuals in the development of a sports ministry in their country.

The World Congress On Sports Executive Committee has also agreed to help with some of your expenses for you to attend the Congress. When we receive your confirmation reply form, we will schedule your flight from the nearest international airport to your home so that you will arrive in Seoul by September 7. Your departure will be scheduled to leave Seoul on Friday, September 16.

INFORMATION SHEET

DATES

The Congress will begin at 7:00 pm on Wednesday, September 7, 1988. We will have a full schedule of meetings and training each day of the Congress except for Sunday, September 11, which is open for you to go to a Korean church, shop, or sightsee. The Congress will conclude the evening of Thursday, September 15, 1988.

HOUSING

The Congress will be held at the Bando Youth Hostel, 679-3, Yeoksam-Dong, Kangnam-Ku, Seoul, Korea. All bedding will be provided. The hostel is approximately a 15-minute ride to the Olympic Sports Complex. The phone number is 567-3111 or 567-2141.

MEALS

All meals will be provided beginning Thursday, September 8, through Thursday, September 15 with the exception of Sunday, September 11. There is a coffee shop in the hostel.

TRANSPORTATION

All transportation for the Congress will be arranged by the Congress Transportation Director unless you have been instructed to arrange your own by the Congress Office. You will be met at the airport upon your arrival and taken on a bus to the Bando Youth Hostel. If you miss our contact person, ask a taxi driver to take you to the Bando Youth Hostel.

OLYMPIC GAMES

The Olympic Games begin on Saturday, September 17, and conclude on Sunday, October 2. Should you decide to stay for some of the Olympics, the Congress will not be able to help you financially with housing, meals, or Olympic tickets. Please make your own arrangements if you plan to stay beyond Friday, September 16.

SHOPPING AND SIGHTSEEING

There will be time scheduled for shopping and sightseeing.

DRESS

The weather in Seoul will be warm during the day and somewhat cooler during the evenings. Bring casual clothing and at least one suit/dress. Congress dress is casual. Please wear traditional clothing for the last evening of the Congress.

Dear Delegate

We are anticipating an exciting World Congress. As the time is getting close, pray that God will prepare you and the leaders of the Congress to be fully empowered for His purpose.

Enclosed are your plane tickets, a Bando Youth Hostel business card, an information sheet to be completed by you, and a few important things to remember.

1. Look carefully at your flight times and flight numbers.
2. Confirm your airline reservations at least three days before departure to make sure there are no problems.
3. Make sure you obtain a visa for ALL countries you are traveling through or traveling to. (South Korea will allow you to obtain a thirty day visa at the airport upon arrival.)
4. Obtain any other documentation that you think you might need to attend this World Congress and return home.
5. Baggage limits for airlines may vary. Make sure you are within the proper weight limit and number of baggage limit for the airline or airlines you are using. Most airlines allow two check-in pieces of luggage and one small carry-on piece with a maximum weight of 44 pounds. Korean Airlines allows more weight.
6. At some airports there will be an airport tax that you will have to pay as you are boarding the plane. Carry additional money to cover this expense. IF you have to pay a tax, obtain a receipt from the official.
7. There will be a host that will meet you at Seoul International Airport upon arrival and will take you back after the Congress has been completed. Upon clearing customs, look for our host holding a "WORLD CONGRESS ON SPORTS" sign. If you miss our host, take a taxi to the Bando (show the driver the business card for the Bando Youth Hostile).
8. Any person who is travelling on scholarship will be reimbursed for any taxes or additional fees required in getting to the World Congress on Sports.

If you find that you cannot attend the World Congress on Sports, please return the tickets. Do not transfer the tickets to someone else or attempt to exchange them for cash. Return the unused tickets to the World Congress on Sports office.

We are looking forward to seeing you in Seoul.

If the passenger's journey involves an ultimate destination or stop in a country other than the country of departure the Warsaw Convention may be applicable and the Convention governs and in most cases limits the liability of carriers for death or personal injury and in respect of loss of or damage to baggage. See also notices headed "Advice to International Passengers on Limitation of Liability" and "Notice of Baggage Liability Limitations".

CONDITIONS OF CONTRACT

1. As used in this contract "ticket" means this passenger ticket and baggage check, of which these conditions and the notices form part, "carriage" is equivalent to "transportation", "carrier" means all air carriers that carry or undertake to carry the passenger or his baggage hereunder or perform any other service incidental to such air carriage. "WARSAW CONVENTION" means the Convention for the Unification of Certain Rules Relating to International Carriage by Air signed at Warsaw, 12th October 1929, or that Convention as amended at The Hague, 28th September 1955, whichever may be applicable.

2. Carriage hereunder is subject to the rules and limitations relating to liability established by the Warsaw Convention unless such carriage is not "International carriage" as defined by that Convention.

3. To the extent not in conflict with the foregoing carriage and other services performed by each carrier are subject to: (i) provisions contained in this ticket, (ii) applicable tariffs, (iii) carrier's conditions of carriage and related regulations which are made part hereof (and are available on application at the offices of carrier), except in transportation between a place in the United States or Canada and any place outside thereof to which tariffs in force in those countries apply.

4. Carrier's name may be abbreviated in the ticket, the full name and its abbreviation being set forth in carrier's tariffs, conditions of carriage, regulations or timetables; carrier's address shall be the airport of departure shown opposite the first abbreviation of carrier's name in the ticket; the agreed stopping places are those places set forth in this ticket or as shown in carrier's timetables as scheduled stopping places on the passenger's route; carriage to be performed hereunder by several successive carriers is regarded as a single operation.

5. An air carrier issuing a ticket for carriage over the lines of another air carrier does so only as its agent.

6. Any exclusion or limitation of liability of carrier shall apply to and be for the benefit of agents, servants and representatives of carrier and any person whose aircraft is used by carrier for carriage and its agents, servants and representatives.

7. Checked baggage will be delivered to bearer of the baggage check. In case of damage to baggage moving in international transportation, complaint must be made in writing to carrier forthwith after discovery of damage and, at the latest, within 7 days from receipt, in case of delay, complaint must be made within 21 days from date the baggage was delivered. See tariffs or conditions of carriage regarding non-international transportation.

8. This ticket is good for carriage for one year from date of issue, except as otherwise provided in this ticket, in carrier's tariffs, conditions of carriage, or related regulations. The fare for carriage hereunder is subject to change prior to commencement of carriage. Carrier may refuse transportation if the applicable fare has not been paid.

9. Carrier undertakes to use its best efforts to carry the passenger and baggage with reasonable dispatch. Times shown in timetables or elsewhere are not guaranteed and form no part of this contract. Carrier may without notice substitute alternate carriers or aircraft, and may alter or omit stopping places shown on the ticket in case of necessity. Schedules are subject to change without notice. Carrier assumes no responsibility for making connections.

10. Passenger shall comply with Government travel requirements, present exit, entry and other required documents and arrive at airport by time fixed by carrier or, if no time is fixed, early enough to complete departure procedures.

11. No agent, servant or representative of carrier has authority to alter, modify or waive any provision of this contract.
