Visto el Oficio N2380-FPLA-89, presentado por la Federación Peruana de Lucha Amateur;

CONSIDERANDO :

Que, la Federación recurrente solicita al IPD autorización oficial para que el señor Victor Enrique Díaz Moscoso, deportista calificado y entrenador, viaje a la ciudad de Olympia-Grecia del 20 de Setiembre al 5 de Octubre de 1989, a participar en una Clínica para Entrenadores programada por la Federación Internacional de Lucha Amateur; Con las opiniones favorables de la Dirección Nacional de Deporte de Afiliados, Oficina de Asesoría Jurídica y Dirección Ejecutiva Nacional; y visto el antecedentes respectivo ;
De conformidad con el Art.9° numeral 12 y Art.77° del Decreto Legislativo N°328 -Ley General del Deporte y su Reglamento aprobado por Decreto Supremo N°07-ED-86; y con cargo a dar cuenta al Consejo Nacional del Deporte ;

SE RESUELVE :

Artículo 1°.- AUTORIZAR, a la Federación Peruana de Lucha Amateur para que el señor VICTOR ENRIQUE DIAZ MOSCOSO, deportista calificado y entrenador, viaje a la ciudad de Olympia-Grecia del 20 de Setiembre al 5 de Octubre de 1989, a participar en una Clínica para Entrenadores programada por la Federación Internacional de Lucha Amateur.

Artículo 2°.- De conformidad con el Art.77° establecido por el Decreto Legislativo N°328 y reglamentado por el Art.76° del Decreto Supremo N°07-ED del 13-03-86, el indicado deportista está exonerado de los impuestos sobre signos de aviación que se contrae el Decreto Legislativo N°209 sobre impuestos a los bienes y servicios del Decreto Ley N°22317 modificado por el Art.2° del citado Decreto Legislativo N°209 y del Impuesto a los viajes al exterior de los Decretos Leyes N°22317 y

Artículo 3°.- El costo que ocasione el indicado viaje afectará el Presupuesto de la Federación Peruana de Lucha Amateur - Recursos Propios y Transferencias Corrientes

Artículo 4°.- La presente Resolución NO AUTORIZA la adquisición de moneda extranjera en el Mercado Unico de Cambios ni en Mesa de Negociaciones.

Artículo 5°.- Al término del citado evento internacional, la Federación Peruana de Lucha Amateur tiene quince (15) días para emitir su Informe Técnico-Económico a la Dirección Nacional de Deporte de Afiliados, el incumplimiento a esta disposición, originará que el IPD no de trámite al próximo pedido de autorización de viaje al extranjero.

Subject : clinic for coaches - Olympia (Greece), September 23 - October 2, 1989

Please find enclosed a circular-letter concerning the clinic for coaches within the framework of the FILA High School, which will be held from September 23 to October 2, 1989 (departure from Athens on October 1 or 2).

On the subject, we would like to give you the following information :

1. The number of participants is limited (1-3 per country).
2. The stay in Athens and Olympia is free of charge.
3. The main subject of the clinic will be the preparation for the 1992 Olympic Games and for the 1996 Olympic Games (Golden Games).
4. Transport in common from Athens to Olympia (approx. 5 hours by bus) is free. Any participant wishing to travel individually from Athens to Olympia will have to pay for his own transport.

The participants will have to make the necessary arrangements for their transport from the airport in Athens to the Hotel Caravelle and vice-versa on the day of departure.

5. Closing date for entries is August 1, 1989. After this date the vacancies still available will be distributed to other countries who wish to participate.

IMPORTANT NOTE FOR DEVELOPING COUNTRIES

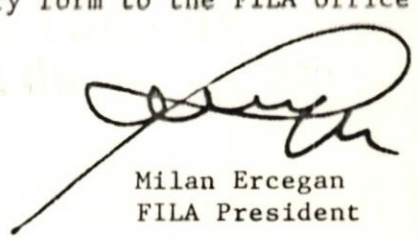
FILA will cover part of the travelling expenses to Athens and return (between Sfr. 500.- and 1'000.-) for one participant per country as per the following criterion :

- a) distance from the country concerned to Athens
- b) participation of coaches in previous clinics
- c) participation of wrestlers in Continental and World Championships
- d) attestation from the National Federation that the participants are really coaches, and not directors or administrators
- e) activity of the country concerned in the development of wrestling
- f) strict respect of the closing date August 1, 1989

The FILA subvention (between Sfr. 500.- and 1'000.- per country) will be paid on the spot in Olympia.

We thank you in advance for returning the enclosed entry form to the FILA office in Lausanne before August 1, 1989.

CLINIC FOR COACHES WITHIN THE FRAMEWORK OF THE OLYMPIC ACADEMY AND UNDER THE PATRONAGE OF THE GREEK NATIONAL OLYMPIC COMMITTEE

A clinic for coaches within the framework of the Olympic Academy and under the patronage of the Greek National Olympic Committee will be held as follows :

1. Place

Olympia (Greece)

2. Date

From 23 September to October 2, 1989 according to the following programme :

September 23 : arrival in Athens
September 24 : departure for Olympia
September 25-30 : clinic for coaches
October 1 : departure for Athens
October 2 : departure from Athens

3. Important note

Please note the following :

- Olympia is rather far from Athens (5 hours by bus).
- It will be necessary to spend a night in Athens.
- Everybody will travel together from Athens to Olympia.
- Owing to the support provided by the Olympic Academy and by the Greek Wrestling Federation, the expenses for the participants will be greatly reduced.

4. Number of participants

- The number of participants is based upon the conditions and capacity of accommodation.
- The maximum number of participants is 150, to include the lecturers.

5. Organization of the clinic

- The preparations for the clinic will be made in co-operation with the President of the Olympic Academy, Mr. N. Filaretos, the Greek Wrestling Federation and their President, Mr. Hamakos, and the FILA Vice-President, Mr. B. Carayannis.
- Participants will be accommodated in the Olympic Academy buildings. Theoretical courses will be held in the same buildings.
- Simultaneous translation into French, English and Greek will be provided by the Olympic Academy.
- Practical courses will be held in the open air. The Greek Wrestling Federation will make the necessary arrangements for :
 - transport of two mats from Athens to Olympia
 - pitching of a tent (shelter from sun and rain)

e) Accommodation and transport

The Olympic Academy will provide :

- accommodation in Athens at the arrival and departure
- transport by bus from Athens to Olympia and back
- accommodation during the clinic in Olympia

6. Organization of the courses

- a) The clinic is opened to all countries.
- b) The clinic will be of a high level.
- c) The purpose of the clinic is to define the method of preparation of the wrestlers for the 1992 Olympic Games and for the 1996 Golden Olympic Games, and in particular the method of preparation applicable to those who will eligible for olympic competition in 1996 (cadets).
- d) A report on the olympic movement and philosophy will be presented, dealing with the following topics in particular :
 - International Olympic Academy
 - Olympic philosophy
 - History of the Olympic Games

7. Financial conditions

These conditions are based upon a participation of 150 persons.

a) The Olympic Academy will bear :

- accommodation at the Hotel "Caravelle"

- hotel and food on September 23 before departure for Olympia and on October 1 upon return from Olympia
- accommodation and food in Olympia
- simultaneous translation
- will place the equipment and installations in Olympia at the disposal of the participants

- b. The Greek Wrestling Federation will provide two wrestling mats and will pitch a tent for protection against rain and sun.
- c. Participants, i.e. their National Federations, will have to pay travelling expenses from their respective countries to Athens return.
The participants will have to make their own arrangements for their transport from the airport in Athens to the Hotel Caravelle and vice-versa.
- d. FILA will pay for :
 - travelling expenses and accommodation for the lecturers
 - participation (between S.Fr. 500.-- and S.Fr. 1'000.--) for the travelling expenses of the participants from developing countries (one leading coach per country)
 - films, video cassettes and books

8. Selection of participants

As the number of participants is limited, the FILA Coaches Commission will define the conditions for the selection of participants.

As a rule, each country cannot send more than one or two coaches. At the request of National Federations, and if there are still some places available, it may be possible to send three coaches.

The host country, Greece, will be allowed to send 10 coaches maximum.

9. Preparation of documentation

On the basis of the programme of the clinic and of the topics presented, the lecturers have to prepare their reports in one of the two FILA official languages - French or English - and send them to the FILA Secretariat in Lausanne before the 1st August, 1989.

10. Entries

The National Federations must send their entries before 1st August, 1989 to the FILA Secretariat in Lausanne.

After 1st August, 1989, the Coaches Commission in agreement with the Director of the FILA High School will invite other coaches to fill in the vacancies.

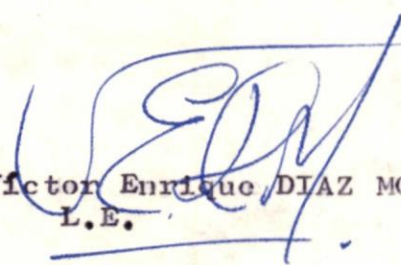
